HOSPITALIZATION / BOARDING CONTRACT

This Agreement is made and entered into this _____ day of _____, 20____, by and between Animalcare Veterinary Hospital, hereinafter referred to as "The Hospital" and

hereinafter called "Client".

1. **Animals:** The Client hereby temporarily transfers possession to The Hospital the following animal(s):

which is/are hereby referred to as "The Animal".

2. **Term of bailment:** This bailment shall commence on the day first written above, and shall terminate at any time requested by the Client, or by The Hospital giving the Client two (2) days advance notice that the Animal is fit to go home and should be collected forthwith, or if the Animal dies. Notice shall be deemed sufficient if given orally or in writing delivered at the above address of the Client or posted at some conspicuous place thereat.

3. **Terms and Conditions of Hospitalization:**

- a) The Hospital shall exercise due care for the safekeeping of the Animal and shall provide all clinical care, surgical procedures, medications and laboratory tests that are necessary to treat and/or cure the Animal or maintain the health of the Animal. Overnight nursing care is only provided by special arrangement.
- b) The Hospital does not guarantee that the treatment given to the Animal will cure it of its ailments.

c) The Client agrees to pay The Hospital for care and safe-keeping of the Animal at rates set forth in a schedule of costs which is available for inspection at the front desk of The Hospital and which the Client admits that he/she has seen and read over prior to execution of this Hospitalization/Boarding Contract.

d) Save that The Hospital will not be liable for loss arising from Acts of God or circumstances beyond its control, in the event the Animal is lost or stolen, The Hospital shall negotiate the value for a like animal in a condition similar to the lost or stolen Animal immediately prior to any such loss.

e) If at the termination of the bailment the Animal is not collected within 10 days from the date of such termination, the Animal will be deemed to be abandoned by the Client and The Hospital shall have full right and liberty to euthanize or sell the Animal in reimbursement of any outstanding fees or costs unless time is extended by agreement in writing and in no event shall The Hospital be liable for any matter arising thereout or therefrom. Any such action as aforesaid shall be without prejudice to the right of action by The Hospital to recover any balance that is due and owing in civil proceedings in the Courts of the Island.

f) The Hospital shall have and enjoy a continuing lien on the Animal pending disbursement of any outstanding fees or costs payable in connection therewith.

4. **This Agreement constitutes the entire understanding of the parties and no representations or promises have been made that are not fully set forth herein.**
